Hospitalisation for heart failure event reporting

As you are all aware, the primary endpoint for REVIVED is all-cause mortality or hospitalisation for heart failure (HHF).

Please report any suspected HHF through the trial database, even if the admission does not meet the trial's current definition. An independent events committee will review all reported events, so there is no harm in over-reporting. On the other hand, under-reporting may mean that genuine HHF events are missed.

REVIVED at BCS Annual Conference

The REVIVED trial team took a field trip up to Manchester to attend the British Cardiovascular Society Annual Conference. Transferring echocardiogram scans

As part of the trial, sites are asked to send a copy of a REVIVED patient's anonymised echocardiograms from baseline, 6-month follow-up visit and 12-month follow-up visit.

When you are preparing the files, it is essential that the following two labels are used:

- REVIVED Study Number, e.g. RV99999
- Study time point, e.g. Baseline

All other labels and identifiers should be removed. This information ensures that the echo core lab team are able to correctly identify and analyse the scans. Files should be sent on either a CD, DVD or USB stick, one scan per disc, to the team at St Thomas' Hospital. Please refer to SOP 012 for further details.
