

Update to the REVIVED randomisation system

Back in May, Sealed Envelope updated the REVIVED randomisation system allowing users to be able to reset their own passwords. In order to be able to do this, users must update their profiles with a back-up email address or telephone number. You can access your profile by clicking on 'My account' in the upper right-hand corner on the 'Trials' page.


We are also urging all site staff to check their login details on the system. For some members, their password may have changed when the system was updated. This is because Sealed Envelope integrated the access to REVIVED alongside other newer trials (e.g. ARREST, ERIC-PPCI and SIMPLE), that they also host.
